AFFIRMATIVE DEFENSES

FIRST AFFIRMATIVE DEFENSE

The putative class, as defined, frustrates the purpose and intent of 15 U.S.C. 1692k(a)(2)(B) which anticipates an absolute cap on statutory damages for any failure to comply with the provisions of the FDCPA.

SECOND AFFIRMATIVE DEFENSE

Upon information and belief, Plaintiffs have contractually agreed to the resolution of the disputes that are the subject of this lawsuit through mandatory individual arbitration. Accordingly, this action should be stayed and the disputes that are the subject of this lawsuit should be ordered to be resolved through mandatory individual arbitration. Arbitration is hereby demanded.

THIRD AFFIRMATIVE DEFENSE

Upon information and belief, Plaintiffs contractually agreed to waive their participation in any class action, whether as class member or class representative, for issues arising from or in any way related to the account at issue in this case. As such, Plaintiffs' class claims should be dismissed.

FOURTH AFFIRMATIVE DEFENSE

Upon information and belief, members meeting Plaintiffs' putative class definition have contractually agreed to waive their participation in any class action, whether as class member or class representative, for issues arising from or in any way related to the account at issue in this case. As such, Plaintiffs' class claims should be dismissed.

FIFTH AFFIRMATIVE DEFENSE

LVNV affirmatively asserts the defense of preemption.

SIXTH AFFIRMATIVE DEFENSE

LVNV affirmatively asserts the defense of *res judicata*, collateral estoppel and/or claim preclusion.

WHEREFORE, Defendant LVNV Funding, LLC respectfully requests that this Honorable Court enter judgment in its favor and against Plaintiff; dismiss Plaintiff's First Amended Complaint with prejudice; and further award all such other relief as is just and appropriate. Respectfully submitted,
